**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That JOHN NYLUND**

of Lebanon, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed branch a tributary of South Santiam River for the purpose of mill pond under Permit No. 16274 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 16, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.5 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 3, Township 13 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the southwest corner of the Ferdinand Krieg, D.L.C. Notification No. 2333, Claim No. 53, T. 13 S. R. 1 West of the Willamette Meridian, Linn County, Oregon; thence South 89° 32' E. along the South line of said D.L.C. 901.56 feet to the westerly right of way line of the County Road; thence, No. 35° 16' W. along said right of way line, 984.26 feet to the southerly right of way line of the Oregon Electric Railroad; thence N. 63° 41' W. along said right of way line 371.77 feet more or less to the west line of said D.L.C. thence, South 961.10 feet, more or less to the place of beginning and containing 11.94 acres more or less except  $\frac{1}{2}$  acre heretofore sold, leaving 11.44 acres more or less conveyed by this deed, in Linn County, Oregon.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
