CERTIFICATE OF WATER RIGHT

This Is to Certify, That RAY KERR OF KERR HOP RANCH

of Route 2, Box 192, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Clear Lake

a tributary of Willamette River

for the purpose of

irrigation
under Permit No. 16281 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from April 25, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.50 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in them. Lot 7 (SW4 SW4), Section 15, Township 6 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.3 acres in NE4 SW4, as projected on Wm. Dorrough D.L.C. 64

16.3 acres in SW4 SW4, as projected on Wm. Dorrough D.L.C. 64
3.2 acres in SE4 SW4, as projected on Wm. Dorrough D.L.C. 64

Section 15,

1.0 acre in NE4 SE4, as projected on Wn. Dorrough D.L.C. 64
3.8 acres in SE4 SE4, as projected on Wn. Dorrough D.L.C. 64
Section 16,

Township 6 South, Range 3 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the South line of the William-Darrow Donation Land Claim in Township 6 South Range 3 West of the Willamette Meridian in Marion County, Oregon, said beginning point being an angle corner in the South line of said claim; thence South 77° 30° West 27.28 chains; thence North 4° West 12.40 chains; thence North 73° East 34.40 chains; thence South 0° 30° West 17.02 chains; thence North 89° 17° West 4.81 chains to the place of beginning. Save and except land conveyed to Jerman Hop Ranch, Inc., a corporation, from Herbert Jerman, a single man, recorded December 23, 1943 in Marion County, Oregon Deed Records.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
