Clark on Page 15665 State Record of Water Right Certificates shall not exceed 0.015 c.f.s. which was the

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

H. M. Fly:

Beginning at a point on the South line of Lot 7 in Section 1, Township 35 South Range 8 West of the Willamette Meridian, Oregon; which point is 606.2 feet west of the southeast corner of said Lot 7; and run thence East 150 feet; thence North 654 feet, more or less to the South bank of Rogue River; thence Westerly along the south bank of Rogue River, a distance of 150 feet, more or less, to a point directly North of the point of beginning; thence South 654 feet to the point of beginning.

Sherman S. Smith:

Beginning at the Southerly bank of Rogue River 1256.2 feet West of the East line of Government Lot 7 in Section 1, Township 35 South Range 8 West of the Villamette Meridian and run thence Westerly along the South bank of Rogue River 100 feet, more or less, to an iron stake; thence Southerly to the Northerly right of way line of the county road; thence Easterly and following the Northerly right of way line of the county road to a point directly South of the point of beginning; thence North to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
