CERTIFICATE OF WATER RIGHT

This Is to Certify, that frank sparks, sherman dahl & marvin w. clark

of 108½ S. Sixth Street, Grants Pass, State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Watertrough Creek

atributary of Rogue River for three families, including the irrigation of a garden not exceeding 1/2 acre in area for each family under Permit No. 16307 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 14, 1945, and is identical with the priority of the right recorded on Page 15664 State Record of Water Right Certificates ; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.015 cubic foot per second; provided that the total quantity of water allowed under this right and under the right confirmed by certificate recorded in the names of H. M. Fly and Sherman S. Smith on Page 15664 State Record of Water Right Certificates shall not exceed 0.015 c.f.s. which was the capacity of the pipe when final proof was made,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NEL, Section 1, Township 35 South, Range 8 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 7 (SW NE4) Section 1, T. 35 S., R. 8 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Sherman Dahl:

Beginning at the Southerly bank of Rogue River 906.2 feet West of the East line of Government Lot 7, in Section 1, Township 35 South Range 8 West of the Willamette Meridian and run thence Westerly along the South bank of Rogue River 100 feet, more or less, to an iron stake; thence Southerly to the Northerly right of way line of the county road; thence Easterly and following the Northerly right of way line of the county road to a point directly South of the point of beginning; thence North to the point of beginning.

Marvin W. Clark:

Beginning at the Southerly bank of Rogue River 1006.2 feet West of the East line of Government Lot 7 in Section 1, Township 35 South Range 8 West of the Willamette Meridian and run thence Westerly along the South bank of Rogue River 200 feet, more or less, to an iron stake; thence Southerly to the Northerly right of way line of the county road; thence Easterly and following the Northerly right of way line of the county road to a point directly South of the point of beginning; thence North to the point of beginning.

Frank Sparks:
Beginning at the Southerly bank of Rogue River 1206.2 feet West of the East line of Government Lot 7 in Section 1, Township 35 South Range 8 West of the Willamette Meridian and run thence Westerly along the South bank of Rogue River 50 feet, more or less, to an iron stake; thence Southerly to the Northerly right of way line of the county road thence Easterly and following the Northerly right of way line of the county road to a point directly South of the point of beginning; thence North to the point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
