CERTIFICATE OF WATER RIGHT

This Is to Certify, That **WALTER LEISY**

of **Silverton**, State of **Oregon**, has made proof to the satisfaction of the **STATE ENGINEER** of Oregon, of a right to the use of the waters of **Silver Creek** a tributary of **Pudding River** for the purpose of **irrigation** under Permit No. **16525** of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from **August 17, 1945**

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **0.013 cubic foot per second**

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the **SE $\frac{1}{4}$ NW $\frac{1}{4}$** , as projected on **John Barger D.L.C., Section 2, Township 7 South, Range 1 West, W. M.**

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to **one-eightieth** of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed **2 $\frac{1}{2}$** acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.6 acre in NE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on John Barger, D.L.C.
0.4 acre in SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on John Barger, D.L.C.
Section 2,
Township 7 South, Range 1 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point on the Northerly boundary line of a parcel of land covered by deed recorded in Vol. 159 Page 75 Record of Deeds for Marion County, Oregon, which is South 33° 32' East 280.96 feet and South 55° 32' West 50 feet from the Southwest corner of Lot 8 in Johnsons Addition to Silverton, Marion County, Oregon and running thence South 55° 30' West 214 feet; thence South 34° 30' East 80 feet; thence North 55° 30' East 213 feet; thence North 34° 30' West 80 feet to the place of beginning.

Beginning at a point which is South 33° 32' East 360.96 feet and South 55° 32' West 50 feet from the Southwest corner of Lot 8 in Johnson's Addition to Silverton, Marion County, Oregon; thence South 55° 32' West 213 feet; thence South 33° 32' East 100 feet; thence North 33° 32' East 213 feet; thence North 33° 32' West 100 feet to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
