CERTIFICATE OF WATER RIGHT

This Is to Certify, That THOS. D. WAITE

of 1444 East M St., Grants Pass, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of The Drain a tributary of Applegate River for the purpose of irrigation under Permit No. 18167 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 19, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NE $\frac{1}{4}$, Section 20, Township 36 South, Range 6 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4 acres in the SW $\frac{1}{4}$ NE $\frac{1}{4}$,
Section 20,
T. 36 S., R. 6 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point on the South line of Lot 10 in Section 20, Township 36 South Range 6 West of the Willamette Meridian, which point is due south of a point 1.78 chains South and 15.26 chains West of the meander post on the south line of Rogue River in the line between Sections 20 and 21 in said Township and Range and run thence West 40 rods to the true point of beginning; thence running North 24° West to a point on the meander line of the original survey of Rogue River said point being on the southerly line of a certain parcel of land conveyed by the State of Oregon to J. W. Stringer by deed Vol. 60 page 323; thence westerly along said meander line and the southerly line of said land conveyed to J. W. Stringer to the Northwest corner of lot 13 in said Section 20; thence South 9.04 rods to the Southwest corner of Lot 13; thence East to the true point of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
