CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. H. and LEONA C. CRAMPTON

of Box 264, Glandale , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Cow Creek

a tributary of South Umpqua River supplemental irrigation and stock

for the purpose of

under Permit No. 18171 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Earch 29, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.098 cubic foot per second, being 0.088 c.f.s. for irrigation and 0.01 c.f.s. for stock

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW NT, Section 32, Township 32 South, Range 6 Nest, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—seventieth of one cubic foot per second per acre, or its equivalent for each acre irrigated during the irrigation season from April 1st to October 1st of each year; provided further that the amount of water allowed herein, together with the amount secured under any other right existing for the same lands shall not exceed the limitation allowed herein,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

1.1 acres in the NW1 NW1, 1.7 acres in the SW1 NW1, 3.3 acres in the SE1 NW1, Section 32, T. 32 S., R. 6 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: A tract of land containing 96.75 acres, more or less, situate in the West half of Sec. 32, Twp. 32 S., R. 6 W. W.M., Douglas County, Oregon, more particularly described as follows, to-wit: Beginning at a point located in the County Road II.0 feet North of the center of Sec. 32, Twp. 32 S., R. 6 W. W.M. running thence South a distance of 1335.0 feet to a point; thence West a distance of 728.3 feet to a point in the Southern Pacific R. R. right of way, 10 feet North of the center of the track; thence paralleling said Southern Pacific R.
