CERTIFICATE OF WATER RIGHT

This Is to Certify, That **GLENN HUNTER**

of R. R. Box 9, Applegate, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Thompson Creek a tributary of Big Applegate River, a tributary of Rogue River for the purpose of log pond and fire protection under Permit No. 18247 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 4, 1948

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ -NE $\frac{1}{4}$, Section 32, Township 38 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Jackson County Deed Records, Volume 256, Page 448, property belonging to Glenn and Grace R. Hunter as follows: The Southeast Quarter of the Southwest Quarter, excepting 10 acres, more or less, deeded to Warren D. Mee, and described in Volume 101 of Deeds, Page 565, records of Jackson County, Oregon), and the South Half of the Southwest Quarter of the Southwest Quarter of Section Twenty-eight; the South Half of the Southeast Quarter of the Southeast Quarter, and the South Half of the North Half of the Southeast Quarter of the Southeast Quarter of Section Twenty-nine; all in Township thirty-eight south, Range Four West of the Willamette Meridian, and containing eighty acres, more or less, together with all water rights, and rights in ditches, canals and laterals, and the rights of way therefor, appurtenant to said premises or used in connection therewith.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
