CERTIFICATE OF WATER RIGHT

This Is to Certify, That AMEL and ZELDA M. JOK

of Route 1, McMinnwille , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River

a tributary of Yamiill River, a tributary of Willamette River for

for the purpose of

irrigation under Permit No. 13155 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from January 21, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.175 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE¹₄ WM¹₄, Section 4, Township 5 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acres feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres in NE₃ NE₄, as projected on D.L.C. 39
12.4 acres in NW4 NE₄, as projected on D.L.C. 39
12.1 acres in SW4 NE₄, as projected on D.L.C. 39
8.2 acres in SE₄ NE₄, as projected on D.L.C. 39

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: A part of the tract of land situate in Section 4, Township 5 South, Range 4 West of the Willamette Heridian, in the Donation Land Claim of Henry H. Hyde, Claim #39, Notification #1240, in Yamhill County, Oregon, conveyed to the United States by W. E. Robbins and wife by deed recorded October 22, 1936, in Book 111, Page 623, of the Deed Records of Yamhill County, Oregon, said part being more particularly described as follows, to wit: Beginning at a point marked by a 3/4" iron pipe on the East line of the H. H. Hyde Donation Land Claim, from which point the Northeast corner of said claim bears North 18° 37' 49" West 1473.87 feet as measured along the Donation Land Claim line; Thence South 18° 37' 49" East 453.02 feet along the East line of the Donation Land Claim to a point marked by a 2" iron pipe; Thence South 16° 14; 39" East 696.98 feet along the East line of the Donation Land Claim to a point marked by a 3/4" iron pipe; Thence North 88° 57' 03" West 1888.90 feet along the line common with United States Farm Security Administration Farm Unit #74 to a point marked by a 3/4" iron pipe in the center line of the County road; Thence North 78° 02' 52" West 325.96 feet along the center line of the county road to a 3/4" iron pipe; Thence North 8° 25' 52" West 1033.35 feet along the center line of the county road to a 3/4" iron pipe which is a corner common with Farm Units 74, 72, 73; Thence South 89° 16' East 2019.45 feet along the line common with Unit #73 to the point of beginning; This unit contains 52.570 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
