CERTIFICATE OF WATER RIGHT

This Is to Certify, That RALPH E. WRIGHT

of Route 1, Creswell , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coast Fork of Willamette River for the purpose of

irrigation under Permit No. 11126 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 12, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.05 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE¹₄ SW¹₄, Section 35, Township 19 South, Range 3 West, W. H.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2½ acre feet per acre for each acre irrigated during the irrigation season of each year

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.0 acres in SE4 SW4, Section 35, T. 19 S., R. 3 W., W.M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Beginning at the intersection of the Easterly line of the Southern Pacific Company's Railroad right-of-way with the South line of Section 34, of Township 19 South, Range 3 West, Willamette Meridian, Oregon, and running thence East 22.85 chains to the South east corner of Section 34; thence East 40:00 chains to the quarter section corner on the South line of Section 35, thence North 17.02 chains; thence West 16.00 chains; thence North 7° 30° West 2.52 chains; thence West 17.80 chains to the Westerly line of the County Road; thence South 10° 47° West, 0.42 chains; thence South 88° 35° West 21.50 chains to the Easterly line of the railroad right-of-way, thence along the Easterly line of the railroad right-of-way, South 21° 20° West, 19.84 chains to the place of beginning. Containing 107.93 acres, exclusive of the County Road.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
