## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That FRED HALLINGER

of Beaver , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Nestucea River

a tributary of Pacific Ocean irrigation

for the purpose of

under Permit No. 151115 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Harch 19, 1913

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.82 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SE AND and NV SVA, Section 31, Township 3 South Range 9 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated throughout the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.1 acre in SW\(\frac{1}{2}\) NE\(\frac{1}{4}\) NE\(\frac{1}{4}\) NW\(\frac{1}{4}\) O acres in SE\(\frac{1}{4}\) NW\(\frac{1}{4}\) NW\(\frac{1}{4}\) 12.0 acres in NE\(\frac{1}{4}\) SW\(\frac{1}{4}\) Section 31

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

That portion of the Southwest Quarter of the Northeast Quarter lying Westerly of the big Nestucca River, That portion of the Southeast Quarter of the Northwest Quarter lying Southerly and Easterly of the Roosevelt Highway, that portion of lot two lying Southerly of the Roosevelt Highway, that portion of Lot Three lying Northerly of the big Nestucca River the Northwest Quarter of the Southeast Quarter and the Northeast Quarter of the Southwest Quarter all in Section Thirty-one, Township Three South, Range Nine, West of the Willamette Meridian, subject to a borrow permit covering the Southeast Quarter of the Northwest Quarter and the Northeast Quarter of the Southwest Quarter of Section Thirty-one and the right to ingress and egress over said land until October 1, 1942.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
