## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That W. E. CLANCY

of Route 10. Box 651. Wilwaukie 2, State of Oregon, of a right to the use of the waters of Willamette River

a tributary of for the purpose of

irrigation under Permit No. 15199 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 27, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.004 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream.

The point of diversion is located in the SW1 SE1, as projected on Jacob S. Risley D.L.C. 51,

Section 11, Township 2 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre in SW $_4^1$  SE $_4^1$ , as projected on Jacob S. Risley, D.L.C. 51 Section 11 T. 2 S., R. 1 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Being a part of the J. S. Risley D. L. C. in T. 2 S., R. 1 E. of the WM — bounded and described as follows, to wit:

Beginning at a point which is S. 38° 48' E. 245.00 feet distant and N 51° 12' E. 60.00 feet distant and S. 58° 13' E. 233.27 feet distant from the most Easterly corner of Tract No. 2 "Starkweather Acreage" according to the duly recorded plat thereof, in T. 2 S., R. 1 E. of the WM as the same is duly recorded in Book 16, at page 11, Record of town plats of Clackamas County, Oregon; — Running thence S. 51° 12' W. 505.95 feet to a point on the meander line of the right bank of the Willamette River at low water stage; thence tracing the meander line of the right bank of the Willamette River up stream S 83° 22' E. 132.61 feet; thence N. 51° 12' E. 446.19 feet to a point; thence N. 58° 13' W. 100.17 feet to the place of beginning — containing 1.0324 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
