## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That J. U. GOUDE and D. F. PLUM

of Mapleton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnamed creek

a tributary of Siuslaw River domestic for two families

for the purpose of

under Permit No. 15666 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 22, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.02 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE2 SW2, Section 35, Township 17 South, Range 10 West, V. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to - - - of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Lot 3 (NE NA) Lot 4 (NW NW) Section 2, T. 18 S., R. 10 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Lot Number three containing twenty nine and 79/100 acres in section Two Township 18 South of Range 10 West, also beginning at the North East corner of lot 4, in section 2, Township 18, south of Range 10 West, thence South 1 degree East along East boundary of lot 4, eight chains, to the Siuslaw River, thence North 55 degrees West along River Bank 6.51 chains; thence North 35 degrees East 9.30 chains; thence South 3.35 chains, to place of beginning containing 3 acres, all in Lane County, Oregon.

Also, Commencing on left bank of Siuslaw River, at the Southwest corner of the 3 acres tract described above, thence North 35 degrees East along easterly line of said 3 acre tract 363 feet, thence west 120 feet, thence on a line parallel to first described line 363 feet more or less to left bank of Siuslaw River, thence down stream 120 feet more or less to place of beginning, containing one acre in Lane County, Oregon.

The right to the use of the water for U.2 purposes aforesaid is restricted to the lands or place of use herein described.
