## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That alfred Hanauska

Permit A-1-1500-1249

of Route 1, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Pudding River

irrigation

under Permit No. 15885 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 1, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.13 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NET SWT, as projected on Patrick M. Gleeson D.L.C. No. 49, Section 5, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is place Juse appurtenant, is as follow: 10.0 ac

s in NE SW4, as projected on D.L.C. No. 49, Section 5,

Township 5 South, Range 1 West, W. M.

10.0 acres 5p0. Vol. 23 p348

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at an iron rod in the center of a creek and on the south line of the P. M. Gleason D.L.C. in township 5 South, range 1 West of the W. M. in Marion County Oregon; thence South 88° 35' East along the south line of said claim 17.16 chains to the reentrant corner in the south line of said claim; thence north 18° 36' east 12.18 chains; thence north 78° 46' west 15.68 chains; thence South 23° 21' West 3.985 chains to an iron pipe; thence southerly following the center line of said creek up stream about 12.50 chains to the point of beginning; containing 23.2 acre of land in the P. M. Gleason D.L.C.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
