CERTIFICATE OF WATER RIGHT

This Is to Certify, That ROYCE HINTON

of Sweet Home , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of unnemed stream and urnamed spring a tributary of Wiley Creek, a tributary of South Santiam River for the purpose of

domestic for one family, including the irrigation of 0.1 acre domestic garden under Permit No.15978 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 15, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.01 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEL NWL, Section 35, Township 13 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to — — — of one cubic foot per second per acre,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

SEL W.;

Section 35, T. 13 S., R. 1 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at a point in the center of a county road which is N. 123.5 feet from the S.E. torner of the N. W. quarter of Sec. 35, in Tp. 13 S., Range 1 E. of the Will. Merd., Oregon; thence N. 58 degrees 32' W. along the center of said road 441.5 feet thence N. 31 degrees 28' E. 457.7 feet, to the center of a county road; thence northerly on a curve to the left with a radius of 359.3 feet, a distance of 12.5 feet; thence N. 8 degrees 22' W. 444.9 feet; thence northerly on a curve to the right with a radius of 359.3 feet, a distance of 331.2 feet; thence N. 44 degrees 38' E. a distance of 96.7 feet; thence northeasterly on a curve to the left with a radius of 573 feet, a distance of 140.8 feet, to a point N. of the place of beginning; thence S. 1570 feet, more or less, to the place of beginning, containing 7.26 acres, more or less, all lying in Linn County, State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
