**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** HARRY F. BRITTAN

of Rt. 1, Box 134, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Abiqua Creek a tributary of Pudding River for the purpose of irrigation under Permit No. 16033 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 23, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 19, Township 6 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

2.0 acres in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ ,  
18.0 acres in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ ,  
Section 19,  
T. 6 S., R. 1 E., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Commencing at the SE corner of the SW $\frac{1}{4}$  of the SW $\frac{1}{4}$  of Section 19, in Township 6 South Range 1 East of the Willamette Meridian, the same point being the SW corner of a 46 acre tract of land deeded to John Morley on the 1st day of October, 1877, deed of same being recorded in Marion County Records Book of Deeds, Volume 23, pages 94, 95 and 96; thence North 49.60 chains; thence South 52° East along the County Road 24.72 chains to a point in the County Road leading from Silverton to Marquam; thence South 24° 33' West along last said road 39.25 chains; thence North 65° West 4.00 chains to the beginning and containing 56 $\frac{1}{4}$  acres of land, more or less, and situated in Marion County, Oregon. Save and except approximately five acres heretofore deeded by the same grantors herein to J. L. Lehr and Mary Pauline Lehr, husband and wife, under deed dated August 25th, 1943.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
