## **CERTIFICATE OF WATER RIGHT**

## This Is to Certify, That H. A. KUENZI

of Rt. 3, Silverton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Drift Creek

a tributary of Pudding River

for the purpose of

irrigation

Perrut 411 300 31-49

under Permit No. 16122 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 14, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.25 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the  $NW_4$   $NE_4$ , Section 8, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

20 acres in the NE4 NE4, Section 8, T. 7 S., R. 1 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Commencing Ten Chains South of the Northeast corner of Section Eight, Township 7 South, Range 1 West of the Willamette Meridian, Marion County, State of Oregon; running thence South on the Section line ten chains, thence west ten chains, thence north ten chains, thence east ten chains to beginning, containing 10 acres.

Commencing 2 rods East of the Northeast corner of the Southwest & of the Northeast of Section 8, T. 7 S. R. 1 W. Willamette Meridian, Marion County, Oregon, thence north 42 rods, thence East 38 rods, thence south 42 rods, thence west 38 rods to place of beginning, containing 10 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
