## CERTIFICATE OF WATER RIGHT

## This Is to Certify, That IVAN CHORAK

of Route 3, Corvallis , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of

for the purpose of

irrigation

under Permit No. 16303 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 10, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.18 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SEA NWA SEA, as projected on Harvey Young D.L.C. No. 56, Section 14, Township 12 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 22 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.4 acre in NET SWT, as projected on D.L.C. No. 56,

0.2 acre in SE SW1, as projected on D.L.C. No. 56, 13.3 acres in NW1 SE1, as projected on D.L.C. No. 56,

0.3 acre in Swa SEa, as projected on D.L.C. No. 56, Section 14,

Township 12 South, Range 5 West, W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the northeast corner of Harvey Young's Donation Land Claim #56 in T. 12 S. R. 5 West Will. Mer.; thence south 25° West with the left bank of the Willamette river up stream 27.12 chains; thence west 35.86 chains; thence north 4° east 24.50 chains; thence east 45.50 chains to the place of beginning, containing 100 acres, more or less, in Benton County, Oregon. Except 1.18 acres conveyed to Benton County, Oregon by deed recorded, Book 87, page 95, Deed Records of Benton County, Oregon; and subject to all existing public roads and roadways.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
