CERTIFICATE OF WATER RIGHT

**This Is to Certify, That**      EDWARD A. MOXLEY

of Rt. 1, Box 177, Eagle Point, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Reese Creek a tributary of Rogue River for the purpose of irrigation under Permit No. 16337 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 17, 1945

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.04 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ , Section 10, Township 35 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $4\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season from April 2, to October 31, of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in the SW $\frac{1}{4}$  SW $\frac{1}{4}$ ,  
Section 10,  
T. 35 S., R. 1 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows: Beginning at the corner common to Sections 9, 10, 15 & 16, Township 35 South, Range 1 West, Willamette Meridian; thence N. 375 feet; thence N. 71° E. 225 feet; thence N. 6° E., 108 feet; thence N. 53° 30' E. 156 feet; thence N. 70° E. 364 feet; thence N. 50° E. 172 feet; thence N. 10° E. 146 feet; thence N. 78° E. 95 feet; thence N. 68° E. 100 feet, thence N. 44° E. 84 feet; thence N. 24° E. 136 feet; thence S. 63° E. 100 feet to the west line of the Crater Lake Highway; thence along the west line of the Crater Lake Highway in a southwesterly direction 1231 feet to the south line common between Sections 10 and 15; thence west 878 feet to place of beginning containing 14.33 acres more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
