CERTIFICATE OF WATER RIGHT

This Is to Certify, That GRACE THOMPSON

of 910 Parrish Street, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Mill Creek

a tributary of Willamette River irrigation

for the purpose of

under Permit No. 16846 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from March 13, 1946

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.004 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW4 SW4, as projected on D.L.C. No. 61, Section 23, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shal

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

0.3 acre in the NW_4^1 SW_4^1 , as projected on D.L.C. 61, Section 23, T. 7 S., R. 3 W., W. M.

Land on which water is to be used is a part of that more explicitly described by appropriator as follows:

Vol. 216 Page 168 Deed Records Fraction South of Block 10 The Oaks Addition to Salem. Beginning at the intersection of the Southerly line of Parrish Street and the Easterly line of Summer Street, running thence Easterly along the Southerly line of Parrish Street 119.4 feet to a point 265 feet Westerly from the intersection of the Westerly line of Capitol Street and the Southerly line of Parrish Street; thence Southerly parallel with Capitol Street 155 feet; thence Westerly parallel with Parrish Street to the center of North Mill Creek; thence Northerly along the center of said Creek to the Easterly line of Summer Street; thence Northerly along the Easterly line of Summer Street to the place of beginning; excepting therefrom a strip of land 5 feet wide extending across the North side adjoining Parrish Street, which is reserved for sidewalk; situated in the City of Salem, Marion County, Oregon.

Also: Beginning at a point which is on a line which line begins at a point on the South line of Parrish Street 215 feet West from its intersection with the West line of Capitol Street, which line runs Southerly and parallel with Capitol Street, said point of beginning being 102 feet South of said South line of Parrish Street; thence Southerly parallel with Capitol Street 53 feet; thence Westerly parallel with Parrish Street 50 feet; thence Northerly and parallel with Capitol Street 53 feet; thence
