CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That W. R. LOFTON of Ironside State of Oregon has a right to the use of the waters of North Fork of Willow Creek, Pole Creek and Beam Creek, tributary to Willow Creek,

for the purpose of the irrigation of 274.5 acres of land, domestic, stock and storage

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 258 ; that the priority of the right hereby confirmed dates from the year 1880 for 25 acres; 1881 for 50 acres; 1887 for 48.5 acres from North Fork of Willow Creek; 1882 for 70 acres; 1883 for 40 acres; 1890 for 10 acres from Pole Creek and 1880 for 31 acres from Pole and Beam Creeks.

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 6.87 sec. ft. from April 1st to May 1st and 3.47 sec. ft. from May 1st to September 1st of each year, or the equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 823.5 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: North Fork of Willow Creek- 4.5 acres in SW 1/4 NW 1/4; 28.5 acres in SE 1/4 NW 1/4; 36 acres in NE 1/4 SW 1/4; 10 acres in NW 1/4 SW 1/4; 34 acres in SW 1/4 SW 1/4; 10.5 acres in SE 1/4 SW 1/4 of Section 25, Tp. 14 S. R. 38 E. W. M., in Malheur County, Oregon.

Pole Creek - 4.5 acres in SW 1/4 NE 1/4; 1 acre in NE 1/4 NW 1/4; 8 acres in NW 1/4 NW 1/4; 1.5 acres in SW 1/4 NE 1/4; 16.5 acres in SE 1/4 NW 1/4; 11.5 acres in NE 1/4 SE 1/4; 8 acres in NW 1/4 SE 1/4; 9 acres in SE 1/4 SE 1/4 of Section 22; 10 acres in SW 1/4 SE 1/4; 1/2 acre in SE 1/4 SE 1/4; 17 acres in SW 1/4 SW 1/4; 4 acres in SE 1/4 SW 1/4 of Section 23, 5 acres in NE 1/4 NE 1/4; 7 acres in NW 1/4 NE 1/4; 6.5 acres in NE 1/4 NW 1/4 of Section 26, Tp. 14 S. R. 38 E. W. M., in Malheur County, Oregon.

Pole and Beam Creeks - 25 acres in NE 1/4 NW 1/4; 16 acres in NW 1/4 NW 1/4 of Section 25, Tp. 14 S. R. 38 E. W. M., in Malheur County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the lands or place of use herein described.
