

CERTIFICATE OF WATER RIGHT

This Is to Certify, That Adelbert Moore

of Ashland

, State of Oregon

, has a right to the use of

the waters of Neil Creek, a tributary of Bear Creek

for the purpose of irrigation of 465.20 acres, and Domestic and Stock use

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson

County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1852;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.00 cubic feet per second.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
