CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That S. M. MOLTHAM of Ironside State of Oregon has a right to the use of the waters of South Fork of Willow Creek and North Fork of Willow Creek, tributary of Willow Creek,

for the purpose of the irrigation of 223.5 acres of land, domestic and stock use,

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of the State of Oregon, in Volume 3, at page 258 ; that the priority of the right hereby confirmed dates from the year 1880 for 86 acres and 1882 for 137.5 acres;

that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow of 5.59 sec. ft. from April 1st to May 1st and 2.80 sec. ft. from May 1st to September 1st of each year, or the equivalent in case of rotation; the total quantity diverted during each irrigation season not to exceed 670.5 acre feet.

A description of the lands irrigated under such right, and to which the water hereby confirmed is appurtenant, or, if for other purposes, the place where such water is put to beneficial use, is as follows: 20 acres in SE 1/4 NE 1/4; 29 acres in NE 1/4 SW 1/4; 10 acres in NW 1/4 SW 1/4 (the foregoing being Government land, the right to water is dependent upon lawful possession of said land by claimant and his grantees) 40 acres in SW 1/4 SW 1/4; 40 acres in SE 1/4 SW 1/4; 13 acres in NE 1/4 SE 1/4; 38 acres in NW 1/4 SE 1/4; 13 acres in SW 1/4 SE 1/4 of Section 21; 20.5 acres in SE 1/4 SE 1/4 of Section 20, Tp. 14 S., R. 39 E. W. M., in Malheur County, Oregon.
