CERTIFICATE OF WATER RIGHT

This Is to Certify, That John and Fred Offenbacher

of Applegate, State of Oregon, has a right to the use of the waters of Applegate River, a tributary of Rogue River

for the purpose of irrigation of 102 acres, Domestic and Stock use in Tract No. 1, and irrigation of 123 acres and Domestic use and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from 1888;

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 2.55 cubic feet per second for Tract No. 1, and 3.00 cubic feet per second for Tract No. 2.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:
