CERTIFICATE OF WATER RIGHT. (For Rights which have been confirmed by the Courts.)

THIS IS TO CERTIFY, That WILLOW RIVER LAND & IRRIGATION COMPANY. c/o Demnis M. Brogan, Director, of Brogan, State of Oregon, has a right to the use of the waters of Willow Creek, a tributary of Halheur River. Phipps Creek. Pole Creek, Black Creek, Gum Creek, Turner / Foison Creek, tributary of Willow Creek, for the purposes of the irrigation of 1734 acres of land, domestic and stock use, and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Malheur County, and the said decree entered of record at Salem, in the Order Record of the STATE WATER BOARD of Oregon, in Volume 3, at page 258; that the priority of the right hereby confirmed dates from Dec. 15, 1872 for the irrigation of 1782 acres in Tract No. 1; 1873 for the irrigation of 457 acres in Tract No. 2; 1877 for the irrigation of 503 acres in Tract No. 3; 1871 for the irrigation of 110 acres in Tract No. 4; 1874 for the irrigation of 52 acres in Tract No. 5: 1882 for the irrigation of 32 acres in Tract No. 6; 1885 for the irrigation of 95 acres in Tract No. 7; 1870 for the irrigation of 146.5 acres in Tract No. 8 and 1904 for the irrigation of 160 acres in Tract No. 9; that the amount of water to which such right is entitled and hereby confirmed for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed a rate of flow for lands in Tp. 14 S. M., of 6.04 sec. ft. from April 1st to May 1st and 3.02 sec. ft. from May 1st to September 1st of each year; a rate of flow for all other lands described below of 37.31 sec. ft. from rebruary 15th to May 1st and 18.67 sec. ft. from May 1st to September 1st of each year; the total quantity diverted from all sources of supply not to exceed 5202 acre feet during each irrigation season.
