CERTIFICATE OF WATER RIGHT

(For Rights which have been confirmed by the Courts)

This is to Certify, That L. E. McBEE,
of Cecil, State of Oregon, has a right to the use of
the waters of WILLOW CREEK, tributary to the Columbia River, in Morrow County,
Oregon,

for the purposes of irrigation and domestic use; (irrigation from January 1st to
September 15th of each year)

and that said right has been confirmed by decree of the Circuit Court of the State of
Oregon for Morrow County, and the said decree entered of record at Salem,
in the Order Record of the Board of Control of the State of Oregon, in Volume 1, at
page 73; that the priority of the right hereby confirmed dates from 1873 for
the irrigation of eighty (80) acres of land and from 1905 for the irrigation
of one hundred and fourteen and five-tenths (114.5) acres of land;

that the amount of water to which such right is entitled and hereby confirmed for the
purpose aforesaid, is limited to an amount actually beneficially used for said pur-
pose, and shall not exceed 1.33 cubic feet per second as of date 1873 and
1.91 cubic feet per second as of date 1905.

A description of the lands irrigated under such right, and to which the water
hereby confirmed is appurtenant, or, if for other purposes, the place where such water
is put to beneficial use, is as follows:

Thirteen (13) acres in NE $\frac{1}{4}$ of SE $\frac{1}{4}$; twenty-six and one-half (26 $\frac{1}{2}$) acres in
SE $\frac{1}{4}$ of SE $\frac{1}{4}$; Sec. 20; twenty-two (22) acres in NE $\frac{1}{4}$ of NE $\frac{1}{4}$; twenty (20) acres in
SE $\frac{1}{4}$ of NE $\frac{1}{4}$; twenty (20) acres in NE $\frac{1}{4}$ of SE $\frac{1}{4}$; eighteen (18) acres in SE $\frac{1}{4}$ of SE $\frac{1}{4}$;
Sec. 29; twenty-four (24) acres in NW $\frac{1}{4}$ of NW $\frac{1}{4}$; eleven (11) acres in SW $\frac{1}{4}$ of NW $\frac{1}{4}$;
Sec. 28; twenty-one (21) acres in NE $\frac{1}{4}$ of NE $\frac{1}{4}$; seven and one-half (7 $\frac{1}{2}$) acres in
SE $\frac{1}{4}$ of NE $\frac{1}{4}$; Sec. 32; ten and one-half (10 $\frac{1}{2}$) acres in NW $\frac{1}{4}$ of NW $\frac{1}{4}$; Sec. 33; All
in Tp. 2 N. R. 23 E., W. M., in Morrow County, Oregon.

The right to the use of the water aforesaid hereby confirmed is restricted to the
lands or place of use herein described.
