under Permit No. 296 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon and daly confirmed by order of the STATE WATER BOARD of Oregon, made and entered

of record in the Record of Proceedings of said Board, at Sulem, in Volume

at page 250 , on the 16th day of June, 1917 ; that the priority of

the right hereby confirmed dates from April 19, 1910 ; that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount uctually beneficially used for said purposes, and shall not

exceed 4.37 cubic feet per second, or the equivalent in case of rotation.
