CERTIFICATE OF WATER RIGHT

This Is to Certify, That **Otto Cantrall and Harlan Cantrall, successors** in interest to **J. H. Devlin & Mary Cantrall, successors in interest to John Devlin, of Ruch**, State of **Oregon 97530**, has a right to the use of the waters of **Little Applegate River, a tributary of Applegate River** for the purpose of **irrigation of 180.5 acres, and Stock use**

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for **Jackson** County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume **4**, at page **1**; that the priority of the right thereby confirmed dates from **September 1, 1857;**

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed **3.60 cubic feet per second.**

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

- 38.6 acres in SE $\frac{1}{4}$ SE $\frac{1}{4}$
