CERTIFICATE OF WATER RIGHT

This Is to Certify, That C. E. Forsythe

of Salem

, State of Oregon

, has a right to the use of

the waters of Coyote Creek, a tributary of Wolf Creek

for the purpose of Mining, Oct. 1 to June 1

and that said right has been confirmed by decree of the Circuit Court of the State of Oregon for Jackson County, and the said decree entered of record at Salem, in the Order Record of the STATE ENGINEER, in Volume 4, at page 1; that the priority of the right thereby confirmed dates from (See below)

that the amount of water to which such right is entitled, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 58.00 cubic feet per second from all sources, subject to the provisions of paragraph 79 of said decree, and as more particularly set forth below.

A description of the lands irrigated under such right, and to which the water is appurtenant (or, if for other purposes, the place where such water is put to beneficial use), is as follows:

Note: C. E. Forsythe also has a right to the use of 8.0 cubic feet per second for Mining, Oct. 1 to June 1 from Boulder Creek, a tributary of Grave Creek, with a date of priority of 1881, to supplement the flow in the Southworth, Smith Feeder, Ash McWilliams, Ruble South Side, Davis and Ferguson ditches, diverting the waters of Coyote Creek for mining purposes; also a right to the use of 8.0 cubic feet per second for Mining, Oct. 1 to June 1, from Clark Creek, a tributary of Grave Creek, with a date of priority of 1881, to supplement the Boulder Creek right by combining the waters of Boulder and Clark creeks and turning it into Coyote to be used for mining purposes through the ditches named under the Coyote Creek right; and a right to the use of 6.0 cubic feet per second for Mining, Oct. 1 to June 1, from Morris Gulch, a tributary of Coyote Creek, with a date of priority of 1879 as a supplemental supply for mining through small ditches acting as feeders for the South Side Ruble Ditch.

And said right shall be subject to all other conditions and limitations contained in said decree. The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
