**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** F. W. KING

of Rt. 1, Box 225, Sherwood, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of an unnamed stream and unnamed springs a tributary of Willamette River for the purpose of irrigation, domestic, stock, and operation of ram under Permit No. 13035 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 9, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.072 cubic foot per second, being 0.052 cubic foot per second from springs for irrigation; 0.008 cubic foot per second from springs for domestic and stock use; 0.002 cubic foot per second from stream for domestic and stock use; and 0.01 cubic foot per second from stream for operation of ram,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$  SE $\frac{1}{4}$ , Section 17 and Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ ), Lot 2 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ ), Section 20, Township 3 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Stock, domestic and ram in the SW $\frac{1}{4}$  SE $\frac{1}{4}$

13.2 acres and stock in Lot 2 (NW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
1.8 acres and domestic and stock in Lot 2 (SW $\frac{1}{4}$  NE $\frac{1}{4}$ )  
2.0 acres and stock in Lot 1 (NE $\frac{1}{4}$  NE $\frac{1}{4}$ )  
0.6 acre and stock in Lot 1 (SE $\frac{1}{4}$  NE $\frac{1}{4}$ )

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows:

- Tract #1. The land beginning one hundred sixty rods west of the northeast corner of section numbered seventeen in township three south of range one east of the Willamette Meridian thence south eighty rods; thence east one rod; thence north eighty rods; thence west one rod to the place of beginning, containing fifty hundredths of an acre.
- Tract #2. The southwest quarter of the northeast quarter of section numbered seventeen, in township three south of range one east of the Willamette Meridian, containing forty acres, more or less.
- Tract #3. The land beginning at the northwest corner of the southeast quarter of section numbered seventeen in township three south range one east of the Willamette Meridian; thence east eighty eight rods; thence south seventy two rods; thence west eighty eight rods to the one-half section line thence north on the one-half section line seventy-two rods to the place of beginning, containing forty acres, more or less.
- Tract #4. The land beginning on line between sections seventeen and twenty in township three south of range one east of the Willamette Meridian, at the west line of land conveyed by Jacob Wortman to Martha L. Arnspiger by deed recorded at page 489 of Book "I" of the records of deeds of Clackamas County, State of Oregon; thence north on said west line twenty-two chains to stake from which a fir tree twelve inches in

diameter bears south 58° 30' east twenty hundredths of a chain and to the south line of the Willis tract; thence west on the south line of Willis tract conveyed by said Wortman to James Willis by deed recorded at page 121 of book "D" of the records of deeds of Clackamas County, State of Oregon, and to the one-quarter section line north and south through section seventeen; thence south on the one-quarter section line in sections seventeen and twenty to the Willamette river; thence down stream with meanders to point south of the place of beginning; thence north on the west line of said Arnspiger land to the place of beginning, containing one hundred twenty acres, more or less.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
