CERTIFICATE OF WATER RIGHT

This Is to Certify, That IDA M. EYRE

of Route 5, Box 401, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of several springs and reservoir constructed under Application No. R-17921, Permit No. R-a tributary of Pudding River for the purpose of 72 irrigation

under Permit No. 13295 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from September 23, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.054 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the $NE\frac{1}{4}$ $NW\frac{1}{4}$, as projected on Rice Dunbar D.L.C. No. 48, Section 29, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

4.3 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Rice Dumbar D.L.C. No. 48 Section 20

T. 7 S., R. 1 W., W. H.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing at an angle in the County road leading from the old Territorial road to Salem at a point which is North 19 degrees 42' East 16.03 chains from the corner of sections 19, 20, 29, 30, T. 7 S., R. 1 W. W. M.; thence S. 86 degrees 20' East in the road 24 chains 44 links; thence S. 30' East on W. Cranston's West boundary 28 chains 3 links; thence West on said Cranston's North boundary 39 chains 43 links thence North 18 degrees 22' East 37 chains 20 links to the middle of the aforesaid county road; thence S. 28 degrees 30' East 6 chains 59 links to the beginning containing 101.3 acres, more or less, situate in Marion County, Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
