CERTIFICATE OF WATER RIGHT

This Is to Certify, That MARIE BERGSTROM AND RALPH HENRY BERGSTROM

of Route 1, McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of

South Yamhill River a tributary of Yamhill River (Willamette River) for the purpose of

irrigation. under Permit No. 13361 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 17, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.70 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW 1/4 SW 1/4, Section 12, Township 5 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent and shall be further limited to a diversion of not to exceed 2 1/2 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 1.2 acres in Lot 5 (NE 1/4 SE 1/4)
  - 25.8 acres in the NE 1/4 SE 1/4, as projected on John Boyd D.L.C. No. 58
  - 8.1 acres in the NW 1/4 SE 1/4, as projected on John Boyd D.L.C. No. 58
  - 0.7 acres in the SE 1/4 SE 1/4, as projected on John Boyd D.L.C. No. 58
  - 2.3 acres in Lot 6 (SE 1/4 SE 1/4)
- Section 11
- 16.8 acres in the NW 1/4 SW 1/4
  - 0.6 acre in Lot 1 (NE 1/4 SW 1/4)
- Section 12

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 11.88 chains South of the Northeast corner of the John Boyd and wife Donation Land Claim Number 58 in sections 10, 11, 14 and 15 in Township 5 South, Range 5 West of Willamette Meridian said point being the Southeast corner of a tract of land formerly owned by L. K. Wallace; thence South 89° 45' West 65.94 chains to angle in Wallace tract; thence South 25.62 chains to the Northwest corner of a tract of land formerly owned by J. R. Martin; thence East on said Martin's North line 48.60 chains to East line of said claim Number 58; thence North 9.00 chains to angle corner in said claim Number 58; thence East 17 chains to the easterly Southeast corner of said claim Number 58; thence North 17.12 chains to the place of beginning, containing 156.62 acres more or less, also the following

Beginning at a point 10.12 chains South and 9.97 chains East of the most Northerly Northeast corner of the John Boyd Donation Land Claim Number 58; thence South 15.70 chains to center of the South Yamhill River; thence North Easterly meandering down the center of said South Yamhill River to a point due East of the beginning point; thence West 19.75 chains to place of beginning. Containing 12 acres more or less, in Section 12, Township 5 South, Range 5 West of Willamette Meridian.

Beginning at the Northerly Southeast corner of said John Boyed Donation Land Claim No. 58; thence West 17.00 chains; thence South 8.60 chains; thence East to South Yamhill River; thence Northeasterly meandering said River to place of beginning, in Section 11 Township 5 South Range 5 West of Willamette Meridian and containing 10 acres more or less, also; Beginning at an angle in the East boundary line of said Donation Land Claim No. 58 at a stake from which a fir tree 24 inches in diameter bears South 16°, West 38.00 chains; thence North 18.75 chains to the Southwest corner of lands previously sold by E. J. Wright to Mason and Gault; thence East 9.97 chains to stake from which a fir tree 17" in diameter bears South 24° West 107 links distant; thence South 15.70 chains to center of South Yamhill River; thence up the center of said River to a point 1.00 chain South of a stake at the beginning corner; thence North 1.00 chain to the place of beginning in Section 12 Township 5 South Range 5 West of Willamette Meridian and containing 17.50 acres more or less, excepting from the first above described premises .57 of an acre more or less heretofore conveyed to Yamhill County for road purposes.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
