State of , has made proof of Route 1, McMinnville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of South Yamhill River

a tributary of Yamhill River (Willamette River) for the purpose of

index permit No. 13362 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 17, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW SW4, Section 12, Township 5 South, Range 5 West. W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second peracre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

5.3 acres in the SWA NEA, as projected on John Boyd D.L.C. No. 58 6.1 acres in the SEA NEA, as projected on John Boyd D.L.C. No. 58
3.3 acres in the NEA SEA, as projected on John Boyd D.L.C. No. 58
4.8 acres in the NWA SEA, as projected on John Boyd D.L.C. No. 58
0.2 acre in Lot 1 (SEA NEA)

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Being part of Donation Land Claim of John Boyd and wife. Notification No. 2417 Claim No. 58 in Township 5 South, Range 5 West of Willamette Meridian, and part of lots number 1, 2 and 3 of section 11 and lots No. 3 and 5 of section 12; which said parts there of more particulary described as beginning on South line of the Richard Miller Donation Land Claim, Notification No. 2359, which said point is 44 1/2 links North of the Northwest corner of said Boyd Donation Land Claim and running thence East 19.45 chains; thence South 5.505 chains; thence West 19.75 chains; thence South 00° 42' East 6.82 chains to angle corner in North line of Henry Lueders land; thence South 89° 52' West 33.54 chains to iron pipe set in center of Count Road; thence North 00° 27' West along center of Count road 12.40 chains to South line of Richard Miller Donation Land Claim; thence East along South line of Richard Miller Donation Land Claim 32.785 chains to point of beginning.
