CERTIFICATE OF WATER RIGHT

This Is to Certify, That L. L. ERNST

of St. Paul , State of Oregon, of a right to the use of the waters of

Horseshoe Lake a tributary of Willamette River for the purpose of

irrigation under Permit No. 13793 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 2, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.375 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 2 (NW4 SE4), Section 23, Township 4 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acro for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Also, Beginning at a point 1.20 chains North and 16.12 chains West of the quarter Section corner between Sections 23 and 2h in Township h South of Range 3 West of the Willamette Meridian, Marion County, Oregon, said beginning point being in the South Boundary line of the Jean Jeangras Donation Land Claim No. 79; thence West along the South line of said claim 23.88 chains to the legal subdivision line running North and South through the center of Section 23 aforesaid; thence South along said subdivision line 18.71 chains, more or less, to the North boundary of the Laurent Sauvie D. L. C.; thence South 89° East 23.88 chains along the said North boundary the spoint due South of the place of beginning; thence North to the place of beginning, containing hh.95

acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
