CERTIFICATE OF WATER RIGHT

This Is to Certify, That ORAL AND N. MARIE WINTERS

of Route 2, McMinnville, State of Oregon, of a right to the use of the waters of Yamhill River a tributary of Willamette River, State of Oregon, of a right to the use of the waters of for the purpose of

irrigation under Permit No. 13389 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from December 23, 1938

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.358 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE4 NE4, Section 14, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

21.4 acres in $SE_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$, as projected on Jacob Haun D. L. C. No. 51 6.9 acres in $NE_{\frac{1}{4}}$ $SE_{\frac{1}{4}}$, as projected on Jacob Haun D.L.C. No. 51 0.3 acre in $SE_{\frac{1}{4}}$ $NE_{\frac{1}{4}}$, as projected on Henry Bird D.L.C. No. 50 Section 11

T. 4 S., R. 4 W., W. M. Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at an angle corner in the North line of the Jacob Hawn Donation Land Claim, said corner being marked by a 2" iron pipe which is North 89º 18: 17" West 2349.77 feet from the Northeast corner of the claim; Thence South 20° 54' 34" East 43.13 feet along the right-of-way line of the Southern Pacific Railroad to a point marked by a 2" from pipe; Thence South 660 00' 33" West 590.55 feet along the South right-of-way line of the Southern Pacific Railroad to a paint marked by a 2" iron pipe; Thence North 23° 59' 27" West 70.00 feet along the right-of-way line of the Southern Pacific Railroad to a point marked by a 2" iron pipe) Thence South 66° 00' 33" West 1377.58 feet along the South rightof-way line of the Southern Pacific Railroad to a point marked by a 2" iron pipe; Thence South 140 05' 56" East 414.36 feet along the line common with the property of the heirs of G. F. Earhart to a point marked by a 2" iron pipe; Thence South 00 33' 17" West 538.36 feet along the line common with Farm Unit No. 59 to a point marked by a 3/4" iron pipe; Thence South 890 04 16" East 2180.17 feet along the line common with Farm Unit No. 60 to a point marked by a 3/4" iron pipe; Thence North 0° 24: 12" East 1746.37 feet along the line common with Farm Unit No. 64 and an undeveloped Farm Unit to a point marked by a 3/4" iron pipe on the North line of the Jacob Hawn Donation Land Claim; Thence North 890 181 17" West 476.77 feet along the North line of the Jacob Hawn Donation Land Claim to the point of beginning; Also, beginning at a point marked by a 2" iron pipe on the North right-of-way line of the Southern Pacific Railroad, said point being 1h3.36 feet South of and 585.13 feet West of an angle point in the Jacob Hawn Donation Land Claim, said angle point

being marked by a 2" iron pipe; Thence North 23° 59' 27" West 148.30 feet to a point on the Southerly right-of-way line of Oregon State Highway No. 99 West as relocated; Thence Southwesterly along said Southerly right-of-way line to a point marked by a 2" iron pipe, said point being South 8° 53' 14" West 662.42 feet from the Northeast corner of the Henry Bird Donation Land Claim; Thence South 14° 05' 56" East 153.79 feet along the line common to the heir of G. F. Earhart to a point marked by a 2" iron pipe on the Northerly right-of-way line of the Southern Pacific Rail-road; Thence North 66° 00' 33" East 1363.62 feet along the North right-of-way line of the Southern Pacific Railroad to the point of beginning; This Unit contains 76.592 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
