CERTIFICATE OF WATER RIGHT

This Is to Certify, That FRANK BURBANK

of Box 14, Arago, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Coquille River a tributary of --- for the purpose of

irrigation under Permit No. 13667 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 8, 1939

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.82 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 1 (NW $\frac{1}{4}$ NW $\frac{1}{4}$), Section 31, Township 28 South, Range 12 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.9 acres in Lot 1 (NW $\frac{1}{4}$ NW $\frac{1}{4}$)

40.3 acres in Lot 1 (NE $\frac{1}{4}$ NE $\frac{1}{4}$)
7.2 acres in Lot 2 (NW $\frac{1}{4}$ NE $\frac{1}{4}$)
2.2 acres in SE $\frac{1}{4}$ NE $\frac{1}{4}$, as projected on David Hall D.L.C. No. 38

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the Northeast Corner of Section Thirty-six, Township Twenty-eight South, Range Thirteen, West of the Willamette Meridian, running thence West 42.32 chains to the Northeast Corner of the Arago Clay Products Company's land, thence South 29° 45' West 20.15 chains to the Southeast Corner of said Company's land, thence West 7.75 chains to the Quarter Section line, thence South along said line to the Northwest Corner of the Thomas R. Schroeder land deeded to him by the widow and several heirs of J Henry Schroeder, deceased, and described in a deed recorded in Volume 79, page 344 of Deeds, recorded in the Office of the Clerk of Coos County, Oregon, thence South 62° 29' East 113.4 feet along the North side of the said Thomas R. Schroeder place to the Northwest Corner of the W. H. Schroeder place, thence South 57° East 9.47 chains to the Northeast Corner of said W. H. Schroeder place, thence South 32° 10' West 1.97 chains to the North side of the County Road, thence South 53° 30' East 8.85 chains along the North side of the County Road to Meander line on left bank of Coquille River near Hall's Prairie Landing, thence along meander line down stream North 44° East 5.60 chains, North 66° East 18.50 chains, North 39° East 11.20 chains, North 58° 30' East 4.10 chains to the meander corner on the East boundary of Section Thirty-six, thence North along said boundary 17.60 chains to the place of beginning, excepting all that portion lying South and West of a line

beginning at a iron pipe 958.58 feet South and 698.92 feet West of the North Quarter Section Corner of Section Thirty-six, running thence South 56° 45' East 1375.00 feet to an iron pipe, thence South 32° 30' West 220.00 feet to an iron pipe, thence South 53° 30' East 900 feet to an iron pipe on the left bank of the Coquille River.
Also Lot 1 in Sec. 31 Township 28 S. R. 12 W. W. M.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
