CERTIFICATE OF WATER RIGHT

This Is to Certify, That LUDWIG-HITZ

of Route 2, Box 115, Woodburn , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Butte Creek a tributary of Pudding River for the purpose of

irrigation under Permit No. 1993 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from June 22, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.97 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE4 NE4, Section 22, Township 5 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one—eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing on the West boundary of the Donation Land Claim of Joseph Magone and wife in Township 5 South, Range 1 West of the Willamette Meridian, Marion County, Oregon, at the terminal point of the division line between said Joseph Magone and wife; thence North 32 degrees East in accordance with said division line 56.8h chains to the East boundary of aforesaid land claim; thence North 2h degrees 15' West on claim line a distance of 5.65 chains; thence South 6h degrees 12' West 48.7 chains to the West boundary of claim; thence South 55 degrees 18' East on Claim line 35.98 chains to the place of beginning.

Save and except from the foregoing description all of that part situated East and North of Butte Creek in Clackamas County, said premises hereby described being situated in Marion County, Oregon.

Also, commencing on the West boundary of the Donation Land Claim of Joseph Magone and wife, at a point where is planted a large stone from which a cedar tree 3 feet

in diameter and marked with two notches about h feet from the ground, bears North 86 degrees 10' West, 72 links distant; thence West 28.86 chains to the legal subdivision line dividing the Northwest quarter of Section 22, Township 5 South, Range 1 West of the Willamette Meridian, Marion County, Oregon, into East and West halves; thence North on said subdivision line, 5.86 chains to the center of the Northwest quarter of said Section 22; thence East on the legal subdivision line, 20 chains to the legal subdivision line dividing the Section into East and West halves; thence North on said legal subdivision line, 11.80 chains to its intersection with the West boundary of the aforesaid Magons Claim; thence South 25 degrees h8' East on the Magone line, 19.80 chains to the place of beginning.

Also, save and except the land described in deed from P. H. Seely and Irma Seely, his wife, Delbert Seely and Mary Seely, his wife, to Herman Kuper and Hattie F. Kuper, his wife, dated March 8, 1939, recorded March 8, 1939, in Volume 23h, Page 51h, Deed Records for Marion County, Oregon.

The rijnt to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
