CERTIFICATE OF WATER RIGHT

This Is to Certify, That PAUL STAEDELI

of Rt. 3, Box 143, Silverton, State of Oregon ⁹⁷³⁸¹, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Silver Creek and Pudding River, a tributary of - - - for the purpose of irrigation under Permit No. 14483 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 11, 1940

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.29 cubic foot per second, being 0.22 cubic foot per second from Silver Creek and 0.07 cubic foot per second from Pudding River,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, Section 32, Township 6 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.6 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Gideon S. Cox D.L.C.
 2.0 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on Wesley Plummer D.L.C.
 5.6 acres in the NW $\frac{1}{4}$ SE $\frac{1}{4}$, as projected on Gideon S. Cox D.L.C.
 Section 32
 T. 6 S., R. 1.W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Commencing at a point where the road leading from Salem to Silverton, Oregon, intersects the line between the lands formerly owned by Wright Foshay and H. D. Mount in Section 32, Township 6 South, Range 1 West of the Willamette Meridian, in Marion County, Oregon; said beginning point being the Northeast corner of the lands shown in Vol. 84, Page 406, Deed Records for Marion County, Oregon; thence South 84° West to the Eastern boundary of the Donation Land Claim of David H. Smith and wife; thence South 12° West along said Eastern line to the middle of Pudding River; thence up the middle of said Pudding River to the mouth of Silver Creek; thence up the middle of Silver Creek to a point where the same intersects the East line of that certain 120.00 acre tract of land described in a deed recorded in Vol. 25, Page 359, Deed Records for Marion County, Oregon; thence North on said East line to the Northeast corner of said 120.00 acre tract; thence West to the Northwest corner of said 120.00 acre tract; thence North to the place of beginning, and containing 58.00 acres, more or less.
