CERTIFICATE OF WATER RIGHT

This Is to Certify, That ALFRED POOLE

of Route 1, Stayton , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Alder Creek and North Santiam River for the purpose of irrigation under Permit No. 14537 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 9, 1940:

that the amount of water to which such right is entitled and hereby confirmed, for the purposes

aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.152 cubic foot per second, being 0.13 cubic foot per second from Alder Creek, and 0.022 cubic foot per second from North Santiam River,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE_4^1 NW $_2^1$ from Alder Creek and SE_4^1 SW $_4^1$ from North Santiam River, Section 17, Township 9 South, Range 1 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Lots No. 2 and 7 of Section 17, Township 9 South, Range 1 East of the Willamette Meridian, Oregon, SAVE AND EXCEPT THEREFROM the following described tract of land: Beginning at the Northwest corner of said Lot #7, running thence South 40 rods, thence East 40 rods, thence North to the North line of said Lot #7, thence West to the place of beginning. The tract of land being conveyed hereby containing 65.26 acres of land more or less, all being situated in the County of Marion, State of Oregon, except that a part thereof may be situated in the County of Linn, State of Oregon, by reason of the changing of the main stream of the Santiam River.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
