## CERTIFICATE OF WATER RIGHT

## This Is to Certify. That CHARLES A. EVANS

of Route 1, Box 280, Independence , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Hayden Slough

a tributary of Rickreall Creek

for the purpose of

irrigation
under Permit No. 14811 of the State Engineer, and that said right to the use of said waters
has been perfected in accordance with the laws of Oregon; that the priority of the right hereby
confirmed dates from March 22, 1941

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.63 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE\(\frac{1}{4}\) NE\(\frac{1}{4}\) SE\(\frac{1}{4}\) and NW\(\frac{1}{4}\) SE\(\frac{1}{4}\), as projected on Bethuel Dove D.L.C. No. 59 and Catherine Fudge D.L.C. No. 60, Section 3, Township 8 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightleth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed  $2\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at an iron pipe 7.30 chains East and 6.04 chains North 48° 30' East from the Southwest corner of the Catherine Fudge DIC # 60 situated in Sec. 3, Township 8 South, Range 4 West of the Willamette Meridian, Polk County, Oregon, and thence East 29 chains more or less to the west bank of Hayden Slough in said Dection, Township, and Range, thence along west bank of said slough with the meander thereof, to the South line of land owned by T. C. Muller, thence west along South line of said Muller land to the East boundary of State Highway # 51, thence Southerly along East boundary of said State Highway # 51 to a point due West of the place of beginning; thence East 4 chains more or less to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
