**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** FRANK BATES

of Hebo, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Three Rivers a tributary of Nestucca River for the purpose of irrigation under Permit No. 15271 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from May 12, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.20 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 13, Township 4 South, Range 10 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, of its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point south 39° 21' east 1157.4 feet from the northwest corner of the southeast quarter of the southeast quarter of Section 11, Township 4, south of Range 10, west of the Willamette Meridian, said point being on the east line of the C. C. Jensen tract and being the center line of Three Rivers; thence south on the east line of said C. C. Jensen tract 1746.31 feet to the south line of the Lars Jensen Claim; thence south 89° 28' east 916.7 feet along said south line; thence north 695.54 feet, more or less, to a point which is 1954.9 feet south and 1648.1 feet east of the northwest corner of the southeast quarter of the southeast quarter of Section 11; thence north 57° 10' east 337.9 feet to the Matoon fence line; thence along said Matoon fence line north 21° 23' west 93.8 feet; thence north 5 23 1/2 west 254.2 feet to an iron pin; thence north 70° 08' east 163.94 feet to fence line of Albert Mason tract; thence north 35° east 313.74 feet along said fence line to center line of County road; thence north 19° 40' west 451.3 feet along center line of County road to line of H. L. and D. Jensen; thence north 89° 30' west 1304.54 feet along said line to C. C. Jensen line; thence south 208.6 feet to place of beginning; all in Sections 11, 12, 13 and 14, Township 4, south of range 10, west of the Willamette Meridian.

EXCEPTING therefrom .50 acre, more or less, conveyed to D. A. Bailey and Eliza Bailey, by deed recorded in Book 59 at page 135 and also excepting 1 acre

conveyed to the State of Oregon by deed recorded in book 48 at pages 82 and 83 of the Deed Records of Tillamook County, Oregon. AND subject to easement to Pacific Telephone and Telegraph Company to erect and Maintain poles, wires and fixtures upon and across land as shown by record in book 59, page 514, records of Tillamook County, Oregon. Also, excepting a tract conveyed by the grantors herein to the State of Oregon, and a tract of an acre, conveyed by the grantors herein to Chester Lanktree.

*The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.*
