CERTIFICATE OF WATER RIGHT

This Is to Certify, That REUBEN EGGIMAN

of Route 3, Silverton, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pudding River, a tributary of Molalla River, for the purpose of irrigation under Permit No. 15356 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from August 25, 1942

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.19 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ NW $\frac{1}{4}$, Section 8, Township 7 South, Range 1 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

15.0 acres in the NW $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on the Thomas C. Shaw D.L.C. No. 51
Section 8

T. 7 S., R. 1 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the east line of the Donation Land Claim of T. C. Shaw, 10.12 chains North from the S. E. corner of said Claim in T. 7 S., R. 1 W., W. M., Marion County, Oregon. Thence North 30.48 chains, along the east line of said T. C. Shaw Claim, to an iron rod in the middle of the County Road. Thence S. 64° 45' W. 19.45 chains, to an iron pipe in the middle of the County Road. Thence S. 0° 15' W. 20.93 chains. Thence East 1.76 chains. Thence South 1.18 chains, to the north line of the Sharr Estate. Thence East 15.85 chains, to the place of beginning and containing 46 acres of land.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
