CERTIFICATE OF WATER RIGHT

This Is to Certify, That R. M. FITZMAURICE

of Route 4, Box 342, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Pringle Creek atributary of Willamette River for the purpose of

irrigation under Permit No. 15440 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from Karch 8, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.0375 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 3 ($SW_{4}^{1}SW_{4}^{1}$), Section 2, Township 8 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

3.0 acres in Lot 3 (SW 3 SW 4) Section 2 T. 8 S., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the North boundary line of "A" Street in Oak Hill Tracts as the same appears of record at page 10 of Book 4 of Town Plats for Marion County, Oregon, which is 70.84 feet South 88° 30' East and 704.9 feet South 0° 21' West from the Southeast corner of the Donation Land Claim of F. R. Smith and wife in Township 8 South of Range 3 West of the Willamette Meridian in Marion County, Oregon; and from thence running South 0° 21' West sixty (60) feet to the South boundary line of said "A" Street; thence East 12 feet to the West boundary line of Section 2 in said Township and Range; thence South 0° 21' West along the West boundary line of said Section 2, 595.36 feet to a point 310.2 feet North 0° 21' East from the Southwest corner of said section 2; thence North 89° 38' East 257 feet; thence North 0° 21' East parallel with the West boundary line of said Section 2, 655.36 feet to the North boundary line of said "A" Street extended; thence Westerly along the North boundary line of said "A" Street and the extension thereof to the place of beginning; save and except all roads and rights-of-way, also subject to an easement for a roadway sixty (60) feet in width commencing at the Easterly end of said "A" Street in Oak Hill Tracts, as the same appears of record at page 10 of Book 4 of Town Plats for Marion County, Oregon, and continuing upon the course of said "A" Street to the easterly boundary of the land conveyed herein, as set out and described in the deed from Ama S. Thielsen and F. D. Thielsen to M. L. Whitesell and Alice Whitesell, dated the 25th day of August, 1925.
