**CERTIFICATE OF WATER RIGHT**

**This Is to Certify, That** WM. VANDECOEVERING

of Route 2, Forest Grove, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of West Fork Dairy Creek, a tributary of Tualatin River, for the purpose of irrigation under Permit No. 15462 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from February 8, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.95 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SE $\frac{1}{4}$  NW $\frac{1}{4}$ , Section 17, Township 1 North, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 32.2 acres in the NE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Chas. Conklin D. L. C. No. 53
- 29.3 acres in the SE $\frac{1}{4}$  SW $\frac{1}{4}$ , as projected on Chas. Conklin D. L. C. No. 53  
Section 17
- 14.5 acres in the NE $\frac{1}{4}$  NW $\frac{1}{4}$ , as projected on Chas. Conklin D. L. C. No. 53  
Section 20  
T. 1 N., R. 3 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Part of the Donation claim of Charles Conklin, being Claim No. 53 in T 1 N R 3 W Willamette Meridian, Washington County, Oregon; more particularly described as beginning at a point 21.21 chains west of the south-east corner and 22.70 chains north of the south line of said claim and running thence north 26.90 chains, to the north line of the claim, thence west with said line, 16.34 chains to a stake, thence south 26.90 chains to a stake, thence east, parallel with said north line, 16.34 chains to the place of beginning, containing 44 acres.

Also being part of the Charles Conklin D L.C No. 53, in T 1 N R 3 W Will. Mer. and being part of a tract of 80 1/4 acres. The tract herein conveyed being bounded and described as follows, to-wit:

Beginning at an iron the S E corner of said 80 1/4 acre tract, running thence north 22.35 chains to an iron the S E corner of a tract formerly conveyed to Peter Vandecoevering, thence S. 89° 35' W. 16.39 chains to an iron the S W corner of said tract formerly conveyed to Peter Vandecoevering; thence south 4.83 chains to north line of Catholic Cemetery; thence east 1.48 chains to N E corner of said Cemetery; thence south 6.60 chains to S E corner of said cemetery; thence west 1.18 chains; thence south 1.05 chains to an iron; thence S. 89° 35' E. 15.94 chains; to an iron; thence south 9.65 chains; thence S. 89° 35' E. 25 links to place of beginning, and containing 20 acres.

Also being part of the Charles Conkling D.L.C. No. 53 in T 1 N R 3 W., Will. Mer., and being part of a tract of 80 1/4 acres. The tract herein conveyed being bounded and described as follows, to-wit:

Beginning 30 links S. 89° 35' E. of a stone, the S.W. CORNER of said 80 1/4 acre tract, running thence S. 89° 35' E. on South line of said D.L.C. 4.33 chains; thence north 30 links; thence S. 89° 35' E. Parallel with south line of claim, 11.61 chains to a point 25 links N. 89° 35' W. of an iron the S.E. corner of said 80 1/4 acre tract; thence North parallel with east line of said tract 9.65 chains to an iron; thence N. 89° 35' W. 15.94 chains to an iron; thence south 9.95 chains to place of beginning, and containing 15.51 acres.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
