CERTIFICATE OF WATER RIGHT

This Is to Certify, That A. W. CROCKER

of Route 5, Box 88, Salem , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River

a tributary of Columbia River

for the purpose of

irrigation

Permit A-1-300-1-4

under Permit No. 15538 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 7, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 1.05 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the Lot 5 (NW $\frac{1}{4}$ SE $\frac{1}{4}$ and SW $\frac{1}{4}$ SE $\frac{1}{4}$), Section 10 and Lot 10 (NW $\frac{1}{4}$ NE $\frac{1}{4}$ and SW $\frac{1}{4}$ NE $\frac{1}{4}$), Section 15, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: The Donation Land Claim of Jefferson Chitwood being the Lots numbered 5, 6 and 7 of Section 10, and Lots numbered 8, 9 and 10 of Section 15 in Township 7 South of Range 3 West of the Willamette Meridian, in Polk County, Ore.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
