of Box 89, McMinnville , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Dear Creek

a tributary of Yamhill River irrigation

for the purpose of

under Permit No. 15545 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 15, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.256 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW4 NW4, as projected on Robert Henderson D.L.C. No. 49, Section 23, Township 5 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed $2\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

h.7 acres in the SE¹/₄ NE¹/₄, as projected on Robert Henderson D.L.C. No. 19 Section 22

0.8 acre in the NW4 NW4, as projected on Robert Henderson D.L.C. No. 49 15.0 acres in the SW4 NW4, as projected on Robert Henderson D.L.C. No. 49 Section 23

T. 5 S., R. 5 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point 29.83 chains West of the Southeast corner of the George F. Hibler DLC Not. No. 2372, Claim No. 50, in T. 5 S., R. 5 W. of the Will Mer. in Yamhill County, Oregon; thence south 32.50 chains to an iron pin in the County Road; thence North 89½° W. 65.2 links to a rock; thence North 75 links to a rock from which an oak bears N. 41° W. 104 links; thence W. 28.71 chains to the S. E. corner of "Frost" lands; thence N. 25° E. 10.51 chains to a post from which an oak bears S. 75° E. 18 links; thence N. 7° W. 2 chains; thence N. 38° 30' W. 2.51 chains to an oak on North bank of Deer Creek; thence N. 67° E. 4.12 chains; thence N. 16.50 chains to a stone set on the South line of said George F. Hibler DLC; thence E. 21.92 chains to the place of beginning, containing 74.25 acres, more or less.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
