CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLENN O. LEWIS, SR.

of 955 Terrace Drive, Salem, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Willamette River a tributary of Columbia River for the purpose of irrigation under Permit No. 15570 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from July 9, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.22 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NE $\frac{1}{4}$ SW $\frac{1}{4}$ and SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James White D.L.C. No. 51, Section 22, Township 7 South, Range 3 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

6.0 acres in the SE $\frac{1}{4}$ NW $\frac{1}{4}$, as projected on James White D.L.C. No. 51
2.0 acres in the NE $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James White D.L.C. No. 51
8.7 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James White D.L.C. No. 51
1.0 acres in the SW $\frac{1}{4}$ SW $\frac{1}{4}$, as projected on James White D.L.C. No. 51

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point on the No. Boundary line of the Donation Land Claim of James White & wife, Claim #51 in T87-SR3W. of the Will. Meridian in Polk Co. Ore. which point is 90 ft. W. of the N. E. Corner of said Claim; running thence W. along the No. boundary line of said Claim 13.40 chains to a rock at the No. side of a fir tree, thence So. 1° 21' W. 14.26 chains to an iron pipe; thence So. 89° 30' W. 49 links to an iron pipe; thence So. 2° 15' W. 1.89 chains to an iron pipe; thence So. 59° 40' W. 1.34 chains to an iron pipe; thence So. 46° 5' W. 13.28 chains to a point in the center of the county road; thence So. 23° 5' E. along the center of said road 2.72 chains; thence So. 27° W. 1.59 chains; thence No. 55° E. 4.30 chains, more or less, to the N. E. corner of tract of land sold to S. L. Burk by deed recorded in Vol. 83 Page 315, Polk Co. records; thence So. 37° 10' E. 9.84 chains; thence No. 24° E. 39.85 chains to the place of beginning.

Excepting, lands deeded to S. of O. Hiway Comm. & U. S. Bonneville Comm. located on So. side of described real premises - Subject to easement in favor of P.E.P. Co.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
