CERTIFICATE OF WATER RIGHT

**This Is to Certify, That** R. C. BERRY

of Route 1, Lyons, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of two springs a tributary of \_\_\_\_\_ for the purpose of irrigation, domestic use for one family and stock under Permit No. 15624 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from October 14, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.03 cubic foot per second, being 0.02 cubic foot per second from North spring and 0.01 cubic foot per second from South spring.

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the NW $\frac{1}{4}$  NE $\frac{1}{4}$ , Section 35, Township 9 South, Range 3 East, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$  acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

Domestic and stock in NW $\frac{1}{4}$  NE $\frac{1}{4}$   
0.2 acre in the NW $\frac{1}{4}$  NE $\frac{1}{4}$   
Section 35  
T. 9 S., R. 3 E., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: The Northwest quarter of the Northeast quarter (NW $\frac{1}{4}$  of NE $\frac{1}{4}$ ) of Section No. Thirty-five (35) in Township nine (9) South of Range three (3) east of the Willamette Meridian, Oregon, containing forty (40) acres, more or less, all lying and being situated in the county of Linn, and in the State of Oregon.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
