CERTIFICATE OF WATER RIGHT

This Is to Certify, That GEORGE GATES

, State of , has made proof of Eyrtle Creek , State of Oregon , has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Oregon South Myrtle Creek a tributary of South Umpqua River for the purpose of

irrigation under Permit No. 15633 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from November 27, 1943

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.337 cubic foot per second,

or its equivalent in case of rotation, measured at the point of diversion from the stream. Section 25, Township 29 South, Range 5 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 21 acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall

conform to such reasonable rotation system as may be ordered by the proper state officer. A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

- 2.6 acres in Lot 1 (NE NE 1)

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at a point in the center of county road which is 20.50 chains South and North 40° East 8.20 chains from the Northwest corner of the Hugh Carson and wife donation land claim No. 50 in said section twentyfour, thence South 21° East along center of said road 12 chains, thence South 5° 30' East 3, chains, thence South 18 * East 8 chains to the South line of said claim No. 50, thence East along said South line 31.71 chains to the line Cornelius Cellers' land, as shown at page 378 of Book 47, Deed Records of Douglas County, Oregon, thence North 4° 48' West along the line of said Cellers land 35.20 chains to center of County road, thence Southwesterly along center of said road approximately 35 chains to the place of beginning: Also all of Lot One in section Twenty-five, Township Twenty-nine South, Range Five West of the Willamette Meridian.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
