CERTIFICATE OF WATER RIGHT

This Is to Certify, That GLEN S. MACY

of McMinnville, State of Oregon, has made proof to the satisfaction of the STATE ENGINEER of Oregon, of a right to the use of the waters of Panther Creek a tributary of Baker Creek, a tributary of North Yamhill River for the purpose of irrigation under Permit No. 15752 of the State Engineer, and that said right to the use of said waters has been perfected in accordance with the laws of Oregon; that the priority of the right hereby confirmed dates from April 14, 1944

that the amount of water to which such right is entitled and hereby confirmed, for the purposes aforesaid, is limited to an amount actually beneficially used for said purposes, and shall not exceed 0.338 cubic foot per second

or its equivalent in case of rotation, measured at the point of diversion from the stream. The point of diversion is located in the SW $\frac{1}{4}$ NW $\frac{1}{4}$, Section 4, Township 4 South, Range 4 West, W. M.

The amount of water used for irrigation, together with the amount secured under any other right existing for the same lands, shall be limited to one-eightieth of one cubic foot per second per acre, or its equivalent for each acre irrigated and shall be further limited to a diversion of not to exceed 2 $\frac{1}{2}$ acre feet per acre for each acre irrigated during the irrigation season of each year,

and shall conform to such reasonable rotation system as may be ordered by the proper state officer.

A description of the place of use under the right hereby confirmed, and to which such right is appurtenant, is as follows:

12.3 acres in the SW $\frac{1}{4}$ NW $\frac{1}{4}$
4.6 acres in the NW $\frac{1}{4}$ SW $\frac{1}{4}$
Section 4
10.0 acres in the SE $\frac{1}{2}$ NE $\frac{1}{4}$
0.1 acre in the NE $\frac{1}{4}$ SE $\frac{1}{4}$
Section 5
T. 4 S.; R. 4 W., W. M.

Land on which water is to be used is a part of the property more explicitly described by the appropriator as follows: Beginning at the SE corner of the Donation Land Claim of Russell Welch and wife Claim #37 thence E, 19.44 chains to a stake thence S. 33 $\frac{3}{4}$ ° W. 35.00 chains to a stake thence N. 80° W. 21.40 chains to a stake in the center of the county road, thence N. 21° W. 8.75 thence N. 42° W. 1.75 chains thence W. 1.75 chains thence N. 19 $\frac{1}{2}$ ° W. 17.21 chains to a post or stake thence E. 33.96 chains to the place of beginning.

The right to the use of the water for the purposes aforesaid is restricted to the lands or place of use herein described.
